Item 1 - Minutes of Previous Meeting (4 February)

These were approved as circulated.

Item 2 - Extending the "Talks" Working Week

Following a short discussion, the Committee agreed to recommend to the various Strand Chairmen that the use of available time be maximised on each of the three normal working days between 1030 and 1730. In addition the Committee agreed to recommend that "doubling up" of meetings should occur thus permitting Liaison Sub-committees and Strands meetings to be scheduled simultaneously or at overlapping times Furthermore it was agreed that extending talks business into a fourth working day be retained as an alternative for future consideration but not implemented now.

Item 3 - Scheduling of Next Review Plenary

The Committee agreed that the Chairman of the Plenary should be asked to seek the views of participants on this issue during the course of business in the week commencing 2 March.

Monday 9 March

Strand One meeting at 1030-1330 and 1430-1730. Liaison Sub-committee on Decommissioning at 1030 (for up to 3 hours).

Tuesday 10 March

Strand Two meeting at 1030-1330 and 1430-1730. Liaison Sub-committee on Confidence Building Measures at 1030 (for up to 3 hours).

Wednesday 11 March

Strand Three Liaison meeting at 0930. Further Cross Strand meeting - (timing to be confirmed following meeting on 2 March).
