THEY DESERVE ATTENTION.

Two important resolutions were introduced into the constitutional convention yesterday.

There is no forbidding clause in the constitution of Kansas. The result is that pretty nearly every county in the state has voted railroad bonds.

A good financial credit is a boon to any state, but particularly a new one. If no provision such as that proposed by Mr. Jeffrey is adopted it may prove in certain contingencies no very difficult task to so manipulate the legislatures that the people's money may be recklessly or thoughtlessly voted away.

Mr. Grant's resolution was a provision for the adoption of the Australian system of voting here. Wyoming needs not only a more closely guarded ballot box, but it also needs a more rigidly regulated citizenship law.

Our election scheme will stand a good deal of modification. While a constitution is being framed what is the objection to providing that the real estate of all secret societies be assessed on exactly the same basis as that owned by private individuals?

A SUGGESTION.

Col. W. R. Steele, now of Deadwood, but formerly of this city, is in town meeting a host of old friends who are delighted to see him after an absence of eight years.

The greatest mistake which has been made in all the constitutions lately adopted in the West is either in incorporating into them cranky notions or elaborating them so as to usurp the legislative functions.

That we may profit by the mistakes committed elsewhere is what induces THE LEADER to suggest that Col. Steele be invited to address the convention today.

ACCORDING to the Las Vegas Optic constitution making is surrounded with many more difficulties in New Mexico than it is in Wyoming. The Optic says: "Wyoming is just beginning to agonize over a constitutional convention to prepare that territory for statehood."

County Commissioners' Proceedings.

COUNTY CLERK'S OFFICE. CHEYENNE, Laramie County, W. T., Monday, August 19, 1889.

The board of county commissioners met in special session this day at 10 o'clock a. m. Present: Geo. W. Hoyt chairman, T. Dyer and John Morrison commissioners.

The clerk submitted the certificate of the territorial auditor showing the assessment for Laramie county made by the territorial board of equalization on the property of corporations for the year 1889 under the provision of section 3839 revised statutes of Wyoming.

On motion it is ordered that Dr. Wyman be appointed county physician for Laramie county from October 1, 1889, until further notice at a salary of \$75 per month.

On motion the board adjourned until Monday, Sept. 2, 1889.

The board of county commissioners met this day at 2 o'clock pursuant to adjournment. Present: Geo. W. Hoyt, chairman, and T. Dyer, commissioner.

The board proceeded to divide and adjust the number of miles of Union Pacific railway and Western Union telegraph and the amounts of same falling within each precinct, township or school district in Laramie county as follows:

School District No. 1. Union Pacific Railway company: 32.03 miles at \$9,640.00 per mile, \$308,769.20.

Western Union Telegraph company: 6 miles, 7 wire at \$224, \$1,344.00. 15.01 miles, 7 wire at \$182, \$2,731.82.

Western Union Telegraph company: 52.04 miles, 1 wire at \$36, \$1,873.44.

Western Union Telegraph company: 30.38 miles at \$9,640 per mile, \$292,863.20.

Western Union Telegraph company: 30.38 miles, 7 wire at \$182, \$5,529.16.

The clerk was instructed to extend the above amounts against the property of respective districts in making out the annual tax list.

On motion it is ordered that the bonds of the treasurers of the several school districts be fixed at the following amounts respectively, to-wit:

School district No. 4, \$2,800.00. School district No. 5, \$3,200.00. School district No. 6, \$900.00.

School district No. 7, \$1,800.00. School district No. 8, \$1,200.00. School district No. 9, \$3,700.00.

School district No. 11, \$800.00. On motion the board adjourned.
